This announcement is made in accordance with Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and the Inside Information Provisions (as defined in the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board (the “**Board**”) of directors (the “**Directors**”) of YGM Trading Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) wishes to inform the shareholders and potential investors of the Company that the Company is expected to record a consolidated loss attributable to shareholders for the year ended 31 March 2026 (“**FY2026**”) of not more than HK\$40 million, representing a significant increase as compared to the loss attributable to the shareholders of approximately HK\$24 million recorded for the year ended 31 March 2025. The Board is of the view that such increase in the expected loss for FY2026 was mainly due to (1) the fair value loss on investment properties and (2) the impairment loss on intangible assets.

The information contained in this announcement is solely based on the information currently available to and the preliminary review by the Group’s management of the unaudited sales and other financial information of the Group for FY2026, which are subject to finalisation and adjustments and have not yet been audited, confirmed or reviewed by the Company’s independent auditor or its audit committee. Therefore, the actual consolidated results of the Group for FY2026, which are expected to be released by the end of June 2026, may differ from the information contained in this announcement. Shareholders and potential investors of the Company are therefore advised to peruse the results with care when the results announcement is released.

Shareholders and potential investors are advised to exercise caution when dealing in the shares of the Company.
